

LLANISHEN AND LISVANE SCOUT GROUP

Welcome to the Scout Group. Here is some useful information about your Scout Group for you and your parents. Now that you have become a new Beaver, Cub, Scout or Young Leader, you have become part of a large and active Scout Group. We hope that you will enjoy your time with us and also as part of the larger family of Scouting.

Scouting was started by Robert Baden Powell in 1907 when he took a group of young boys to a Scout camp on Brownsea Island. They enjoyed it so much that they urged him to form groups around the country that could learn Scouting skills. Thus Scouting was born and it is thriving in most countries of the world. You are now part of a very large international organisation.

Llanishen and Lisvane Scout Group was formed in 1931. It first met in the Vicarage rooms (on the site of Old Vicarage Close) moving in 1957 to Livsey Hall, which was built by the Parents and Scouts. More details of the history of the Group can be found elsewhere on our website. Parents, now that your son or daughter is a member of the Group, you become members too. All the parents on the Group Executive are volunteers. The GE runs the Group, maintains our Scout Halls, Livsey and Fraser, and organises fundraising events. They will ask for your help with fundraising, maintenance and cleaning of the Halls and surroundings. Please support their efforts when asked.

The Leaders in the Scout Troop, Cub Pack and two Beaver Colonies are all dedicated volunteers who have given many years of active service to Scouting. They are passionate about delivering the message that Scouting is a multi faceted, fun, inclusive, adventurous, learning and sociable activity for its' members. All the Leaders are CRB checked, have taken part in training, including first aid and have their warrants regularly reviewed. We are always short of Leaders so you may be asked to help with your child's section. We hope you will volunteer to assist, when asked. If you are interested in helping regularly or in becoming a Leader, speak to Hilary Ashton, Group Scout Leader or your Section Leader.

We currently collect subscriptions each term, £30 for first child, £25 for siblings. These are payable by cheque, made out to Llanishen and Lisvane Scout Group. Please print and complete the Gift Aid form, then hand it to your Leader. This helps us to raise money, by claiming an extra 25% on subscriptions. If you are having any difficulty paying Subs, speak to Hilary in confidence.

Please also complete the other forms, Data Protection, permission to take and use your child's photo and the Membership details form, which assists us in compiling our database.

Communications with parents are by e-mail. Please check your e-mails regularly and respond promptly when asked. If you have a problem with your computer / internet, let us know, so we can give you a paper copy. To find out what is happening in the Group and Sections, check out the website, which is regularly updated.

Tax claimed by The Scout Group:

28p of tax on every £1 you gave up to 5 April 2008.

25p of tax on every £1 you give on or after 6 April 2008.
